This Memorandum of Understanding (MoU) arrived at this 7th Day of Sept. 2017 between, DARSH COLLEGE OF EDUCATION, GOHANA (HARYANA), an SFS College established under the Act enacted by Director General, Higher Education, Haryana represented through its Principal (Which term or expression unless repugnant to the context or meaning thereof shall be deemed to include its successors and permitted assigns) hereinafter referred to as the **Darsh College Of Education, of the "FIRST PARTY".**

And

CHHOTU RAM ARYA COLLEGE, SONEPAT having its registered office at **Sonepat** , represented through **Dr. Narender Singh**, Principal , **CHHOTU RAM ARYA COLLEGE, SONEPAT** (Which term or expression unless repugnant to the context or meaning thereof shall be deemed to include its successors and permitted assigns) hereinafter referred to as the "**CHHOTU RAM ARYA COLLEGE**", of the "**SECOND PARTY**".

The "**DARSH COLLEGE OF EDUCATION**" and the "**CHHOTU RAM ARYA COLLEGE**" are hereinafter, collectively referred to as the 'PARTIES' and individually as a 'PARTY'.

WHEREAS:

DARSH COLLEGE OF EDUCATION, GOHANA is a Private college which has emerged as a centre of excellence of higher education in Sonepat. Strategically located in the Smart City of Gohana, this College has started carving a niche for itself in the education domain and is rising as a shining star on the horizon of quality education.

CHHOTU RAM ARYA COLLEGE, SONEPAT is affiliated to Maharshi Dayanand University, Rohtak is a premier institution of higher learning in the country.

The Parties have appreciated each other's objectives in promoting Excellence inter alia in common area of interest, imparting knowledge and skills required to operate in the area of Academic, Research and Training and are desirous of putting the broad terms of the intentions into a Memorandum of Understanding (MOU) for the areas identified for co-operation and commit to co-operate to the fullest extent by mutual understanding.

Chhotu Ram Arya College missions to prepare a class of proficient scholars and professionals with ingrained human values and commitment to expand the frontiers of knowledge for the advancement of society.

This MoU is subject to the approval of the respective Statutory Authorities of the parties hereto and subject to changes as may be desired.

The implementation and/or conduct of a programmes, courses or activities as specified in this MOU shall be negotiated and determined mutually by the parties vide separate additional agreement or document to be signed by both parties.

The autonomy of each party shall not be diminished, nor constraints be imposed on to carry out the MoU.

The development and implementation of specific forms of cooperation based on this MoU will be separately established/ decided between parties and outlined in executive protocols, specifying the nature of joint activities, financial and other arrangements.

NOW THE MEMORANDUM OF UNDERSTANDING WITNESSES AS FOLLOWS:

In the interest of establishing a relationship of mutual benefit to both organizations, **Chhotu Ram Arya College, Sonipat** and **Darsh College of Education, Gohana** have agreed to the areas of collaboration on academic and research related activities as mentioned in this MoU.

1. Objectives:

- 1.1. To contribute further to the regional understanding between faculty and staff of **Chhotu Ram Arya College, Sonipat** and **Darsh College Of Education, Gohana** for enhancing skills of students/aspirants through internship and vocational training in order to enhance the quality of Technical and Engineering education in the Country.
- 1.2. To strengthen collaboration between **Chhotu Ram Arya College, Sonipat** and **Darsh College Of Education, Gohana** through academic programs in instruction, research and faculty development among the faculty and students of both parties.

2. Scope

The Scope of collaboration on academic and research activities in this Memorandum of Understanding includes the following categories:

1. Developing research projects jointly and avail funding
2. Exchange of academic information, materials and facilities
3. Students Exchange
4. Faculty and Staff Exchange
5. Research aid to Ph.D. scholars by both parties
6. Intellectual property rights of the collaboration work belonging to both parties
7. Organizing/ participation in Joint symposia, seminars, conferences, workshops etc.
8. Developing articulations for twinning/joint programs and allowing students to undertake part of the programme/course of study at each organization; and

9. Promoting such other activities/programs as mutually agreed from time to time

2.1 Developing research projects jointly and avail funding

Both the parties agree to undertake research projects/activities through sharing of research ideas, data and academic resources that can lead to joint publications, development of any product or other intended outcomes like Intellectual property rights/ patents/discoveries generated out of the research activities, belonging to both parties. Such collaboration activities will also include joint research conferences, visitations and sabbaticals at each other's premises; subject to mutual consent of both the parties. All such joint research activities will be governed by the terms and conditions lay down by separate written agreement by both organizations.

2.2 Exchange of academic information, materials and facilities

Both parties agree to exchange academic information, facilities, resources etc. as mutually agreed from time to time.

2.3 Students Exchange

2.3.1 Student Exchange Programs

Both the parties agree to develop programs whereby the students of either organization can have the opportunity to study at the other organization with mutual recognition of the credit hours arising there from. It is desired by both organizations that there will be significant flow of students in exchange as reciprocal. Both parties agree to facilitate internship facilities for exchange students as mutually agreed. Pursuant to the specific agreement for academic exchange, **Chhotu Ram Arya College, Sonipat** and **Darsh College of Education, Gohana** will exchange students according to the terms and conditions laid out by separate written agreement by both organizations.

2.3.2 Short Courses/ Summer School

These courses, usually two to four weeks in duration, will normally be held in spring or summer as mutually agreed. The programs will facilitate visits by students and faculty to learn about the industry environment and culture. In addition to various topics on industry operations and culture, the course would include meetings with industry executives, and visits to various industrial establishments. The cost and other terms of such programs will be mutually worked out separately each year.

2.4 Faculty and Staff Exchange

Both organizations agree to develop opportunities for faculty to teach courses, conduct seminars and undertake such other activities at each other's campus as mutually agreed.

Visiting faculty will be provided with opportunities to observe and share teaching methods and curriculum. **Chhotu Ram Arya College, Sonipat and Darsh College of Education, Gohana** will exchange faculty according to the terms and conditions as mutually agreed upon.

2.5 Organizing/ participation in Joint symposia, seminars, conferences, workshops etc.

Both organizations will promote their faculty and staff participation in the conferences, conclaves and seminars organized by each other to strengthen the ties between both the organizations and will also jointly organize symposia, seminars, conferences, workshops and other programs as mutually agreed.

3. Advertising & Publicity

Both the parties will publicly advertise the collaboration under this MoU among students, staff etc., if agreed by their management. Where reasonably possible, in making advertisements or public announcements in relation to this MoU, each organization shall acknowledge the participation of other organization and the contribution that other organization has made if any.

4. Commencement, renewal, termination and amendment

This MOU will come into force upon affixing of the signatures of the representatives of the both organizations and will remain in effect for Five (5) years. This MOU will be renewed upon its expiry, as per mutual agreement of both organizations. If either organization wishes to terminate the MOU at the end of the three years' period or in between the period of three years, it must notify the other organization not less than six months prior to the expiry of the MOU. The event of termination will not affect participants from completing their activities at the host party already initiated or ongoing unless otherwise mutually agreed. This MoU, its renewal and the actions taken under it will be reviewed at any time. Modifications to MoU will be made by mutual consent and any amendment or extension to the MoU will be formalized by the exchange of letters and or emails between the two organizations.

5. Coordinators:

Each organization agrees to appoint an overall Coordinator for the administration of this MOU. The Coordinator will serve as the contact person on campus. These coordinators will ensure smooth flow of communication and would be responsible to ensure that necessary approvals are in place for student/faculty exchange, articulation agreement etc. These coordinators will be responsible to ensure the effectiveness and enforcement MOU. Both organizations are responsible for keeping their contact details up to date.

6. Resolution of Disputes and Governing law:

In the event of any unforeseen issues or matters not covered herein or any controversy, dispute or difference arising out of or in connection with this MoU, the same shall be resolved amicably by both the organizations. This MoU and further agreements will in all respect be governed by and construed in accordance with the laws of Republic of India.

This MoU shall be signed in counterpart. Each counterpart will constitute the document and these counterparts taken together, shall constitute one and the contact details and address of the designated coordinators are given hereunder:
